

**Camp Bayouca (CNY Baptist Youth Camp)**

Paintball

**Assumption of Risks and Release Form/Image release permission**

Camp Bayouca requires parents of all participants to sign this Agreement to Participate, Assumption of Risk, and **Release Form** in order to be eligible to participate in the Program. The undersigned acknowledges an understanding of the following:

1. Although Camp Bayouca’s goal is to maintain the physical, emotional, and social safety of each participant in the Paintball Program, the physical, emotional and social risks must be assumed by each participant.
2. The level of participation in the Paintball Program is voluntary and “challenge by choice” prevails at all times. No participant is required to do anything that he or she does not want to do.
3. Paintball is a strenuous activity in which players can and do get injured including lower body, mid-section, upper body, and head. In addition, marks are usually left on the skin when a paintball makes contact with the participant. Certain information must be made known to the facilitators’ conducting the program so they are prepared to respond appropriately if the need arises. This information will be held in strict confidence. It must be provided to Camp Bayouca prior to participating in the Paintball Program to maximize the safety of all. \*\*\*Please note that Camp Bayouca cannot make a medical determination regarding a person’s physical fitness to participate in paintball activities. Only the participant and the participant’s parents/guardian or participant physician can do that.

I understand that the Camp Bayouca Paintball activity may be physically and emotionally demanding. I recognize and accept the risks involved in Camp Bayouca’s Paintball activity, and I assume the risks of physical and emotional injury that could result from these activities. In consideration of the above, I have and do hereby assume all of the risks of participation in the Paintball Activity and will hold CNY Baptist Youth Camp, Inc. dba Camp Bayouca, its employees, agents, trustees, officers, and affiliates harmless from any and all liability, actions, causes of actions, claims, and demands of every kind and nature whatsoever, whether for bodily injury, property damage or loss or otherwise, which my child now has or which may arise from or in connection with my participant in Camp Bayouca’s Paintball program and activities. I, along with my family or heirs, understand and agree that we cannot sue CNY Baptist Youth Camp, Inc. dba Camp Bayouca, its employees, trustees, affiliates and associates, and if I do, I cannot collect any money. In addition, I will pay for Camp Bayouca’s attorney and court fees associated with any litigation I might bring against Camp Bayouca, its employees, agents, trustees, officers, affiliates and associates. I also state that neither I am nor my child (if I am signing on behalf of my child) is under or will be under the influence of any chemical substance including alcohol, either at the time of the signing of this Agreement or at the time of participating in Paintball activities. I fully understand that my child’s physical activity involves the potential risk of injury. I also understand that my child’s participation in Camp Bayouca’s Paintball program and activities is entirely voluntary and I give permission to use any photographs taken of me or my child at this event for the promotional use of Camp Bayouca, including our website and social media sites.
